Notwithstanding the foregoing, you acknowledge and agree that during any periods when you are a covered borrower under the Military Lending Act your credit card will be secured by any specific Pledge of Shares you grant us but will not be secured by all shares you have in any individual or joint account with the Credit Union. For clarity, you will not be deemed a covered borrower if: (i) you establish your credit card account when you are not a covered borrower; or (ii) you cease to be a covered borrower.

#### Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are 10 or more days late in making a payment.

Balance Transfer Fee (Finance Charge) - Mastercard Platinum Secured: 2.00% of each balance transfer.

<u>Cash Advance Fee (Finance Charge):</u> 2.00% of each cash advance.

<u>Returned Payment Fee:</u> \$25.00 or the amount of the required minimum payment, whichever is less.

<u>Returned Convenience Check Fee:</u> \$25.00 or the amount of the returned convenience check, whichever is less.

<u>Rush Fee:</u> \$27.50 second day.
