

Official Rules — YOUR SLICE OF SUMMER Sweepstakes

Sponsored by Community Resource Credit Union

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. OPEN TO LEGAL RESIDENTS OF THE STATE OF TEXAS WHO ARE AT LEAST 18 YEARS OF AGE AT THE TIME OF ENTRY.

1. Sponsor

The “Your Slice of Summer” Sweepstakes is sponsored by Community Resource Credit Union, 3110 Rollingbrook Dr, Baytown, TX 77521 (the “Sponsor” or “CRCU”).

2. Eligibility

The Sweepstakes is open to legal residents of the State of Texas who are (a) at least eighteen (18) years of age at the time of entry, and (b) members in good standing of CRCU as defined by CRCU’s Membership Policy. The following individuals are NOT eligible to enter or win: employees, officers, directors, and agents of CRCU and its affiliated entities; employees of any vendor, agency, or contractor involved in the development or administration of this Sweepstakes; and the immediate family members (spouse, parent, child, sibling, and their spouses) and household members of any of the foregoing.

3. Promotion Period

The Sweepstakes begins on June 1, 2026 at 12:00 AM Central Time and ends on August 31, 2026 at 11:59 PM Central Time (the “Promotion Period”). Sponsor’s computer is the official time-keeping device.

4. How to Enter

AUTOMATIC ENTRY METHODS (no purchase, fee, or payment required; however, normal account activity is required to earn automatic entries):

- **DEBIT CARD ACTIVITY:** Eligible members receive one (1) entry for every ten (10) qualifying CRCU debit card signature or PIN-based point-of-sale transactions posted during a Weekly Period. Entries stack (20 transactions = 2 entries; 30 = 3 entries). ATM transactions, declined transactions, and credit card transactions do not qualify. Entries continue to be earned during August; August entries roll into the Grand Prize master file.
- **LOAN FUNDING:** Eligible members receive five (5) entries for each qualifying CRCU loan funded during a Weekly Period or during August. Qualifying loans include: new and used Auto, Auto Refinances from another lender, First Mortgage, Personal Secured, Personal Unsecured, and Recreational loans (RV, Boat, Motorcycle). HELOCs, Home Equity, credit card accounts, loan modifications of existing CRCU loans, internal refinances, and any loan where the member is an authorized signer but not a primary or co-borrower do not qualify. All loans subject to credit approval.

ALTERNATE METHOD OF ENTRY (AMOE):

To enter without an account transaction, hand-print your full name, street address, city, state, ZIP code, daytime phone number, date of birth, and CRCU member number (if applicable) on a 3x5 card and mail it in a #10 envelope with sufficient postage to:

Each valid mail-in entry receives one (1) entry into the Weekly Drawing corresponding to the week in which it is received (if received during the weekly drawing period of June 1 – August 2), and one (1) entry into the Grand Prize drawing. Mail-in entries received after August 2 will receive one (1) entry into the Grand Prize drawing only. Limit one mail-in entry per envelope. Mail-in entries must be received by August 31, 2026. Sponsor is not responsible for lost, late, misdirected, illegible, or postage-due entries. Mechanically reproduced or photocopied entries are void.

5. Weekly Drawings

The weekly drawing portion of the Promotion Period is divided into nine (9) Weekly Periods, occurring between June 1, 2026 and August 2, 2026. Each Weekly Period begins at 12:00 AM CT on Monday and ends at 11:59 PM CT on the following Sunday. The nine Weekly Periods and drawing dates are:

- Week 1: June 1 – June 7, 2026. Drawing: Friday, June 12, 2026.
- Week 2: June 8 – June 14, 2026. Drawing: Friday, June 19, 2026.
- Week 3: June 15 – June 21, 2026. Drawing: Friday, June 26, 2026.
- Week 4: June 22 – June 28, 2026. Drawing: Friday, July 3, 2026.
- Week 5: June 29 – July 5, 2026. Drawing: Friday, July 10, 2026.
- Week 6: July 6 – July 12, 2026. Drawing: Friday, July 17, 2026.
- Week 7: July 13 – July 19, 2026. Drawing: Friday, July 24, 2026.
- Week 8: July 20 – July 26, 2026. Drawing: Friday, July 31, 2026.
- Week 9: July 27 – August 2, 2026. Drawing: Friday, August 7, 2026.

One (1) winner will be randomly drawn from all eligible entries received during each Weekly Period. The winner will receive a \$200.00 cash prize deposited directly into the winner's CRCU account within fourteen (14) business days of winner verification. Weekly entries do not carry over for the purpose of Weekly Drawings; each week's drawing is conducted from that week's entries only.

No weekly drawings will be held during the period of August 3 – August 31, 2026. Entries earned during this period accumulate solely toward the Grand Prize Drawing.

6. Grand Prize Drawing

All entries earned by all eligible participants during the full Promotion Period (June 1, 2026 – August 31, 2026) will be combined into the Grand Prize Drawing. One (1) Grand Prize winner will be randomly drawn on Friday, September 4, 2026. The Grand Prize winner will receive a \$2,000.00 prize presented as a physical check made payable to the winner. The check will be delivered at an in-person check presentation coordinated with the winner's home branch, within thirty (30) business days of winner verification and receipt of a completed IRS Form W-9.

7. Prize Details

- **Weekly Prize:** \$200.00 cash (nine winners total). Deposited directly to winner's CRCU account. ARV: \$200.00 each.
- **Grand Prize:** \$2,000.00 presented as a physical check (one winner). ARV: \$2,000.00.
- **Total prize pool ARV:** \$3,800.00.

Prizes are non-transferable and no substitution is permitted except at Sponsor's sole discretion. Limit one Weekly Prize per household during the Promotion Period. A Weekly Prize winner remains eligible for the Grand Prize.

Any federal, state, or local taxes on prizes are the sole responsibility of the winner. For prizes valued at \$600 or more, Sponsor will issue IRS Form 1099-MISC. Winner is required to complete IRS Form W-9 prior to receipt of the Grand Prize.

8. Winner Selection and Notification

All drawings will be conducted by the CRCU Marketing Department under the supervision of CRCU Compliance. Winners will be selected by random drawing from all eligible entries. Odds of winning depend on the number of eligible entries received.

Winners will be notified by telephone and/or email using the contact information on file with CRCU within five (5) business days of the drawing. If a selected winner cannot be reached within seven (7) calendar days after the first notification attempt, or fails to complete required documentation within ten (10) calendar days, the prize may be forfeited and an alternate winner selected.

9. Publicity

Except where prohibited by law, acceptance of a prize constitutes winner's consent for Sponsor to use winner's first name, last initial, branch city, and likeness for promotional purposes in any media, worldwide, without further payment or consideration. The Grand Prize winner specifically consents to participation in a check presentation event, including photography and video for use in CRCU marketing and public relations. Winners will be announced on the campaign landing page and CRCU social media channels.

10. General Conditions

By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding. Sponsor reserves the right to disqualify any individual who tampers with the entry process, acts disruptively, or violates these Rules. Sponsor reserves the right to modify, suspend, or terminate the Sweepstakes for fraud, technical failures, or any cause that corrupts the Sweepstakes.

11. Release

By participating, entrants release and hold harmless Sponsor, its parent, affiliates, subsidiaries, advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, and agents from any and all liability for any injuries, loss, or damage of any kind arising from or in connection with the Sweepstakes or any prize won.

12. Disputes

These Official Rules are governed by the laws of the State of Texas without regard to its conflict of laws provisions. All disputes shall be resolved exclusively in the state or federal courts located in Harris County, Texas.

13. Platform Disclaimers

This Sweepstakes is not sponsored, endorsed, administered by, or associated with Meta Platforms, Inc., Instagram, Facebook, Google, Spotify, or any other social media or audio streaming platform.

14. Privacy
